Applications should include:

- 1. Name and background information such as education, career and/or volunteer experience;
- 2. Area(s) of interest within the Board of Soo Finnish Nordic Ski Club; and
- 3. Experience relevant to the area(s) of interest.
- 4. Declaration of any potential conflict of interest

Board Member Expectations

Board members are expected to:

- Attend regular meetings from September through June to help guide the organization's strategic direction and oversee its activities
- Actively participate in at least one subcommittee, contributing their expertise to specific areas such as finance, fundraising, or programs.
- Advocate for the organization within the community, support its mission
- Adhere to governance best practices typical of the nonprofit sector, including fiduciary duties and conflict-of-interest policies.

Board Member Election Process

All nominations received by the stated deadline will be examined by the Nominations committee. Successful nominations will be presented to the board in advance of the Annual General Meeting. During the Annual General Meeting, each nominee will have an opportunity to introduce themselves and share their vision for contributing to the organization's mission. Members in attendance will then cast their votes, and the individuals with the highest number of

votes will be elected to the board. The results will be announced at the conclusion of the meeting, and the newly elected board members will begin their term immediately.

Board Member Requirements

Following election, board members are required to complete these items, as required by our governing bodies, Cross Country Ski Ontario and Nordiq Canada

- Safe Sport Training
- Understanding the Rule of Two
- Enhanced Police Information Check (E-PIC)

Committees of the Board

Although these committees are typically led by board members, they are also supported by club members who do not sit on the board.

High Performance Committee	Supports the paid Head Coach
Nominations Committee	Helps to fill board vacancies
Operations Committee	Helps lead the direction of the business, Hiawatha Highlands
Programs Committee	Supports the delivery of Youth programs
Race Committee	Supports the hosting of a provincial race every season
Safe Sport Committee	Supports the Safe Sport requirements of the club as directed by Cross Country Ski Ontario
